SENATE BUDGET HEARINGS SET FOR HEALTH AND HUMAN SERVICES AGENCIES

No. 37

The Senate Finance Committee has scheduled budget hearings for all state agencies. (A *tentative* schedule for health and human service agency hearings is below.) At these hearings, state agencies will testify about the Legislative Budget Board's funding recommendation for their agency in the FY 98-99 biennium. Concerned citizens, organizations, and advocates are also invited to testify. The hearings will be held in the Senate Finance Committee Room (E1.036) in the Capitol Extension.

The House Appropriations Committee will hold similar hearings after House members 'committee assignments are made.
