## **How Many Texans are Poor?**

In 2006, an estimated 3.8 million people in Texas lived below the federal poverty guidelines. Children accounted for 1.4 million of the state's poor.

The poverty rate in Texas was 16.4% overall in 2006. The Texas rate is 5th highest among states (using a 2004-06 three-year average), after Mississippi (19.8%), Louisiana (17.4%), New Mexico (17.1%), and Kentucky (16.5%). The U.S. average is 12.3% (36.5 million people).

# **Texas Poverty Fact Sheet**

## Working, but Poor

Most poor families in Texas include at least one adult who works.

- The federal minimum wage was increased in July 2007 to \$5.85 per hour, or \$12,168 annually for a full-time worker—about 71% of the federal poverty line for a family of three. Before 1980, the federal minimum wage was high enough to keep a family of three out of poverty; by 2006, it had fallen to 65% of poverty.
- Almost 60% of Texas' poor families with children in 2005 had one or more adults who worked half the year or more (26 to 39 weeks). About 1.1 million Texas children have parents who will directly benefit from the federal minimum wage increase.

## Poverty vs. Public Assistance

In 1997, when the state had an estimated 3.3 million poor residents, 2.1 million Texans were receiving Food Stamps on average each month, or about two-thirds of the poor. The cash assistance (TANF) caseload was only 600,128 per month—fewer than one-fifth of Texans in poverty. Food Stamp caseloads declined to 1.4 million in fiscal 2000, then recovered to 2.3 million by 2007. TANF rolls were down to 133,167 recipients in July 2007.
